The \$31.4 million in grants have been awarded to not-for-profit agencies and local municipalities. These funds will be used in rural, suburban, and urban communities, across every area of the State, to make necessary repairs and modifications to the homes of eligible low income households.

These \$31.4 million in awards will be delivered through three DHCR programs:

- The [HOME Program](#) (\$25 million, 1,064 Housing Units) - The HOME program partners with local governments, private developers, and community-based non-profit housing organizations to acquire, rehabilitate or construct housing, or to provide assistance to low-income home-buyers and renters. A total of \$25 million in funding will be provided statewide to build or rehabilitate 1,064 housing units.
- [ACCESS to Home](#) (\$4 million, 307 Housing Units) - ACCESS to Home provides financial assistance to property owners to make dwelling units accessible for low- and moderate income frail elderly and persons with disabilities. These modifications allow individuals to safely and comfortably continue to live in their homes. A total of \$4 million in funding will be provided statewide to make accessibility modifications to 307 housing units.
- [RESTORE](#) (\$2.4 million, 620 Housing Units) -RESTORE (Residential Emergency Services to Offer Repairs to the Elderly) helps low-income elderly homeowners pay for emergency repairs to eliminate hazardous conditions in their homes. A total of \$2.4 million in funding will be provided statewide to make emergency repairs to 620 housing units.



## Hearing Planned On Legislative Proposals

The Commission on Public Integrity will hold a public hearing on its staff legislative proposals to amend the Lobbying Act. The hearing will be in Meeting Room C of the Legislative Office Building at 1 p.m. on Tuesday, September 8.

The proposals, which are being made by Commission staff, would change the Lobbying Act's definition of "lobbying," "expense" and "expenses;" and "gift;" impose a penalty on any lobbyist or client who fails to comply with a Commission audit; establish a civil penalty for use of illegal lobbying contingent retainer agreements; increase the time period for which lobbyists and clients must retain their records; and increase the monetary threshold that triggers filings by lobbyists and clients.

The proposed definition of lobbying – essentially, any paid effort to influence governmental action -- would include matters currently not covered, such as discussions of possible new legislative actions prior to the drafting of legislation.

The proposal to amend the definition of "expense" and "expenses" would include political contributions made by registered lobbyists and their clients. Since campaign contributions are the most common and effective tool that lobbyists and clients have to secure access to elected officials, requiring their disclosure would enhance transparency, a central objective of the Lobbying Act.

## *Report: Housing Markets Appear To Be Stabilizing; Opportunity for Affordable Housing Exists*

Housing markets in many metropolitan areas appear to be stabilizing, but further steep drops in home prices could be seen if the broader economy does not recover, a new report by the National Low Income Housing Coalition (NLIHC) and the Center for Economic and Policy Research (CEPR) finds.

*Hitting Bottom? An Updated Analysis of Rents and the Price of Housing in 100 Metropolitan Areas*, utilizes methodology from two previously released reports to provide an analysis of the current state of the housing market. The report finds that in many markets, home prices are once again tracking more closely to rents, a sign that markets are stabilizing. However, the report also finds that in many markets, the local economy is suffering, which could put off the housing market recovery. In the long-term, the housing market will be robust only with a strong economy in which people have the incomes to afford rents and mortgages.

The report also notes that in many places even as the market stabilizes, new homeowners are likely to be underwater—that is, owing more on their home than the home is worth—for some time to come. Negative equity in a home and high loan-to-value ratios are among the best predictors of foreclosure.

"This report indicates that housing markets are stabilizing at this time," said NLIHC Research Director Danilo Pelletiere, a co-author of the study. "We need to assist this recovery by creating jobs. We should also use the bottom of the market as an opportunity to create affordable housing. Without such proactive efforts to increase the ability of Americans to afford homes, the bottom may prove false."

The report details several policy recommendations that would help strengthen the demand for housing and stabilize markets, including:

- Adequately funding the National Housing Trust Fund to capitalize on current low prices, ensure long-term affordability in a recovery, absorb excess housing, and stimulate employment.

- Stimulating the fundamental demand for housing through acting to lower unemployment and raise wages.

- Recognizing a leading role for rental housing in federal foreclosure mitigation and neighborhood stabilization policy, including allowing foreclosed homeowners to remain in their homes as renters.

# The Luis Arce Success Award

## *Call for Nominations*

The Neighborhood Preservation Coalition of New York State, Inc., calls for nominations for the *Luis Arce Success Award*. This award is given in memory of Luis Arce who passed away on June 23, 1994. Luis exemplified the best in all of us. He unselfishly gave to his family, his community, and all human kind. Luis was a strong community advocate and dedicated his work life to neighborhood revitalization efforts and providing safe, decent and accessible housing for persons with special needs such as developmental disabilities and persons with AIDS.

Luis touched many lives through his work. He was Director of the Manhattan Valley Management Company from 1984 to 1992 and also served as a member of the Board of Manhattan Valley Development Corporation. Through his many years of volunteer work at Sinergia, a non-profit human service and housing organization, Luis championed the integration of persons with disabilities and their families into mainstream housing in the community. Luis also worked at Community Service Society and Solidaridad Humana (Human Solidarity) - an alternative educational institute on the Lower East Side of Manhattan. Luis was a founding board member and remained active in the Neighborhood Preservation Coalition of New York State.

While Luis's life was cut short, his courage and commitment made a difference in his community, in New York State and in the lives of all who knew him.
