JUNE 2021

Application Released

JULY 1, 2021

First Disbursement Available

- If the applicant is approved, the first disbursement will be available no earlier than **July 1, 2021** and upon the successful execution of a Grant Agreement.

JULY 16, 2021

Application Materials Due

- Application materials must be uploaded to the Community Development Online (CDOL) Application System.

AUGUST 2021

2020-21 Annual Performance Report (APR) Released

- The APR is a required document for organizations that were funded in the 2020-21 NRPP Program Year.

SEPTEMBER 24, 2021

2020-21 Annual Performance Report Due

DECEMBER 2021

Mid-Year Report Released / Deadline to Execute

- Mid-Year Reports will be reviewed in the order they are received. If approved, all Grant Agreements MUST be executed by **December 31, 2021**.

JANUARY 3, 2022

Final Disbursement Available

- The final disbursement will be available no earlier than January 3, 2022, upon successful completion of the Mid-Year Report.

FEBRUARY 18, 2022

Mid-Year Report and Audit Due

MARCH 15, 2022

Deadline to submit final payment request

MARCH 31, 2022

If necessary, work plan / budget modification requests due
