## **NeighborWorks America: Empowering Communities for Success**

June 3-10 is NeighborWorks
Week and New York State's
16 NeighborWorks network organizations are joining in a nationwide celebration of "Empowering
Communities for Success."

They will be marking the week with education classes, beautification events, open houses, social media campaigns and more.



New York is second only to California in the number of organizations that are chartered members of NeighborWorks America, a national nonprofit created by Congress in 1978 with the mission to help people live in affordable homes, improve their lives and strengthen their communities.

"While there are nearly 250 chartered NeighborWorks members nationwide, the organizations in New York are some of the most innovative," said Joanie Straussman Brandon, Regional Vice President for NeighborWorks Northeast region.

They include 13 designated
Neighborhood Preservation Companies
that are part of eight NeighborWorks
network organizations. At least five
others have designated Rural
Preservation Companies.

The NeighborWorks Alliance of New York State, the trade group for New York's NeighborWorks network organizations, is a close partner of the Neighborhood Preservation Coalition of New York State (NPCNYS). Working together, the NeighborWorks Alliance and the NPCNYS have increased opportunities for low- and moderate-income communities, garnering new resources, advising policy makers, shaping new programs — in other words, empowering communities for success.

### Training and research for all

NeighborWorks America is known for our professional training in all lines of business relating to affordable housing and community development, and most notably in homeownership education and counseling.

Weeklong NeighborWorks Training Institutes bring practitioners together throughout the country for certificate classes, workshops and special convenings. Currently, we host two in-person training institutes and one virtual training institute annually.

Registration has just opened for the NeighborWorks Training Institute in Chicago, August 21-25. It will feature more than 80 different courses along

## NeighborWorks' Impact in New York State

So how does NeighborWorks benefit New York State? Let's look at the numbers. In FY 2022, NeighborWorks America provided nearly \$6,500,000 in grants from our core appropriation from Congress to network members working in New York. In turn, these organizations:

- > Provided 24,000 customers with housing and counseling services.
- Created 1,100 new homeowners, 56% of which are headed by a person of color.
- > Own or manage nearly 11,000 rental homes.
- > Repaired or rehabbed 5,600 homes.
- Created or maintained 3,000 jobs.
- > Generated \$593,000,000 in investment across New York State.

Asian Americans for Equality contributed to this report.
- Advancing the Promise of Shared Equity Housing Models reports on the potential for shared equity to create lasting affordability, build wealth for people with limited incomes and create vibrant and inclusive communities. Five New York organizations participated in our shared equity initiative: Asian Americans for Equality, Community Development Corporation of Long Island, Hudson River Housing, Ithaca Neighborhood Housing and PathStone.
- From Silos to Collaboration: Building a Health Partner Investment
  Strategy, developed with the Center for Community Investment, presents
  frameworks and tools for leaders who seek to build deep partnerships with
  health organizations to address systemic inequities in disinvested communities. Fifth Avenue Committee was one of six organizations who participated
  in a Health Partner Investment Learning Lab, which helped inform this
  practical and transformational toolkit.



## **ELECTRONIC SIGNATURES:** REQUIRED AND SAFE

Acrobat offers multiple ways to apply a signature depending upon whether the form's creator has included a signature box (you'll see a "sign here" red flag).

The important thing to remember is that applying the signature is the last thing you should do, as it can lock you out of making changes.

- If you need to make changes, delete the signature, save the document then make the changes, reapply the signature and save.
- If there is no signature box, use the "Fill and Sign" feature found under the "Tools" tab and choose "Sign yourself."

Are there other ways to apply signatures? Yes, of course, many... but that's not what HCR is requesting, so stick to the instructions and you'll be fine.

## **KEEPING TRACK**

From past reports, you know the information you're going to be asked to supply on NPP paperwork.

Create spreadsheets or other database-style logs of this information. That way you have it ready to go and can pass it along to the next person who might be responsible for filling out the reports.

A lot of the information required is also requested on other grants. Having information stored in one place can make the application and reporting processes considerably easier.

### AM I REPEATING MYSELF?

A "renewal application" doesn't mean exactly the same information is expected.

And, an "annual report", well, no two years are alike (we certainly learned that in the early 2020s).

When reporting what you will do, or have done, and feel like you're saying the same thing over again, try looking closer at the details.

An ongoing project has multiple phases and many details requiring your ongoing attention. You'll never serve exactly the same number of people in exactly the same way, if you look close enough.

## Prepare now ...

You have a good idea of what's required on HCR applications.
Start pulling together your information now, so you can complete this year's application as soon as possible.

## Statewide Housing Activity Reporting System

## SHARS ID NUMBERS

Statewide Housing Activity Reporting System (SHARS) Identification number.

HCR issues SHARS ID numbers at the start of each program year.

It is 8 digits long and begins with the year; i.e., this year will be 2023xxxx.

You'll need it throughout the year to log into CDOL.

If you use a SHARS ID number that doesn't match the program year of the documents you're submitting, they won't be properly received by HCR.

The SHARS ID number must be the one that corresponds directly with program year of the documents.

Keep it handy with all the other numbers you may use for grants and applications (FEIN, charities, NYS Vendor ID, etc.) 8-digit ID number: 2023XXXX

## **SUBMIT EARLY**

Submitting early is highly encouraged by New York State Homes and Community Renewal (HCR).

Applications and reports are reviewed in the order received, if complete; meaning don't expect it to be considered "received" if you submit only part of what was requested.

Consider the publicized "due date" to be a final submittal date.

Plan administrators are not required to give funding to anyone not meeting the program requirements, which includes submitting by posted deadlines.
